INTRODUCTION

The State Domestic Product is defined as the sum of economic values of all goods and services produced within the State during a specified period of time, usually in a year. It is commonly known as SDP or the State Income.

The Estimates of SDP reveals the true picture of the economy of a State. It is one of the most important economic indicators, which measure the growth and also throw light on the structural changes taking place in the State Economy.

Estimation of SDP is highly a technical work. The data required to prepare the estimate is very huge and the calculation involved is complex in nature. It needs to capture the entire aspects of economy in order to bring out a reliable and dependable information.

Therefore, for the purpose of estimation of SDP, the economy of the State is divided into:-

- (a) Primary Sector
- (b) Secondary Sector
- (c) Tertiary Sector
- (a) Primary Sector:- Primary Sector is further divided into the following sub-sector:-
 - 1. Agriculture (including Horticulture, Sericulture) and livestock.
 - 2. Forestry and logging
 - 3. Fishing
 - 4. Mining and Quarrying
- (b) Secondary Sector: Secondary Sector consists of:-
 - 1. Manufacturing:
 - i. Registered
 - ii. Unregistered
 - 2. Construction
 - 3. Electricity, Water Supply and Gas
- (c) Tertiary Sector:- It consists of the following sub-sectors:-
 - 1. Transport, Storage and Communication
 - 2. Trade, Hotels and Restaurants
 - 3. Banking and Insurance
 - 4. Real Estate, Ownership of Dwellings, Business and Legal Services
 - 5. Other Services

The above sectors are to estimate individually by adopting one or more of the following approaches:-

- 1. Production Approach
- 2. Income Approach
- 3. Expenditure Approach

Production Approach is the most suitable approach for estimation of Primary Sector and Income Approach is mainly adopted for estimation of Services Sector. Expenditure Approach is applies to Construction Sector.

GSDP, NSDP and PCI at Current Price

Income evaluating the current year's Product at the current year's price is termed as Income at current price. The current price estimation is worked out by evaluating all goods and services at current price prevailing in the market during the current year.

The GSDP, NSDP and PCI at Constant Price

The Estimation of State Domestic Product is done both at current and constant prices. The constant price is arrived at by evaluating all the goods and services of the current year at the base year price. The purpose is to eliminate the effect of changes in price and to show the real growth of economy in the State.




Gross State Domestic Product Both at Current and Constant 2004-05 Prices


GSDP by Sectoral Contribution at Current and Constant (2004-05) Prices




Net State Domestic Product by Sectoral Contribution at Current Prices






