**Subject:-Release of Index of Industrial Production, Nagaland, December, 2025.**

**1. Methodology and Timeline**

- 1.1 The Index of Industrial Production (IIP) with base 2011-12 for the State of Nagaland is compiled and estimated by Directorate of Economics and Statistics (DES), Nagaland, Kohima. Following a time lag of 4 week, DES releases State IIP on the 28<sup>th</sup> day of every month or the previous working day if the 28<sup>th</sup> day is a non-working day.
- 1.2 The manufacturing data are directly collected from the producing factories. All together there are nine items for construction of manufacturing index.
- 1.3 Electricity data are gathered from the national power portal.
- 1.4 Mining data are obtained from Directorate of Geology and Mining. Coal is the only item for construction of Mining Index.
- 1.5 The construction of IIP is done in a step by step manner with the use of previous level of indices as indicated below;
  - I. The Item level indices are obtained by multiplying the production relative with 100.
  - II. The subsequent level of indices till general IIP is obtained by the weighted arithmetic mean of the previous level of indices.

**2. Quick Estimate of Index of Industrial Production for the Month of December 2025 (Base 2011-12=100)**

**Current Month Index**

- 2.1 The quick estimate of Index of Industrial Production (IIP) with base 2011-12 for the month of December 2025 is estimated and released on 28<sup>th</sup> January 2026.
- 2.2 The General Index of IIP for the month of December 2025 (Quick Estimates) is estimated to have decreased from 120.45 in November 2025 to 111.65 in December 2025. The decrease in the General Index of IIP was due to the decrease in the Index of Manufacturing and Electricity.
- 2.3 The Manufacturing Sector Index is estimated to have decreased from 408.45 in November 2025 to 372.11 in December 2025.
- 2.4 The monthly generation of electricity as reported by National Power Portal shows that the generation of electricity is 8.30 MU in December 2025. Consequently, Electricity Sector Index is estimated to have decreased from 44.94 in November 2025 to 43.52 in December 2025.

2.5 In the Mining sector, the production of Coal for the month of December 2025 has remained the same as November 2025 at 0 MT. Consequently, the Index of Mining for the month of December 2025 has also remained the same as November 2025 at 0.00.

### **3. Growth of IIP over the Corresponding month of the Previous Year.**

3.1 The General Index of IIP for the month of December 2025 (Quick Estimates) was estimated at 111.65. The General Index of IIP registers a positive growth of 17.95 percent over the corresponding month of the previous year index as shown in **Table-4**.

3.2 The Indices of Industrial Production for Manufacturing, Electricity and Mining sectors for the month of December 2025 was estimated at 372.11, 43.52 and 0.00 respectively and the corresponding growth over December 2024 were estimated at 27.66, 26.33 and 0.00 percent as reflected in **Table-1, 2 and 3**.

3.3 During the month of December 2025, at the Item level, except Plywood and Stone chips, all other items registered a negative growth over the corresponding month of the previous year.

3.4 Summary of the Indices at different level of National Industrial Classification (NIC-2008) for the month of December 2025 is presented in **Table-5**.
